

HAMILTON CITY COUNCIL INNOVATION ENTREPRENEUR AWARD

ENTRY FORM

To recognise a significant innovation and/or entrepreneurial breakthrough, based on underpinning research, associated with the Waikato region and which has potential to ultimately add value to New Zealand.

Criteria

- A demonstrable link with the Waikato. The innovator must have been based principally in the Waikato and/or the innovation was conceived in the Waikato.
- The Innovation can be a product, process, service or application.
- The innovation must be based on scientific research.
- Added-value includes, but is not limited to, direct monetary returns, cost-savings, increased competitiveness and/or new or increased market-share.
- The innovation is judged by international standards by a group of peers, based on science publications, patents and/or any other forms of objective recognition.
- The ability of the innovator to communicate the innovation to a wide (lay) audience.
- The cash award must be spent in such a way to further advance science-based innovation in the Waikato (e.g., paying to bring in an overseas expert, attending an international conference, visiting overseas research organisations, up-skilling in a certain area, etc.) and the winner must provide a letter to the Trust within 12 months of receipt of the award, detailing how the award was used.
- The award will be paid to the individual unless otherwise agreed between the winner and the Hamilton Science Awards Trust.

Eligibility

- The nominee can be an individual or a team.
- The nominee must have performed or directed the work underpinning the innovation.
- The nominee must have recognised qualifications relative to the award being sought. A relevant science qualification is required.
- The recipient must agree to give a nominated lecture or presentation to a high school or general audience if requested.
- The recipient must be prepared to interact with appropriate news media to publicise the research on which the award is based and science in general.
- The winner does not have to be a New Zealand citizen or resident.
- While previous years' outright winners in this award category are encouraged to reapply, they cannot put forward the same piece of work in support of this year's award.
- Previous runners-up in this award category are encouraged to reapply and may re-submit a piece of work already submitted for consideration in past years

The nominee can be self-nominated or nominated by another party who is familiar with the scientist's work. If the scientist is being nominated by another party, that party must be confident all eligibility criteria can be met, including the nominee's willingness to be available for public and media interaction as per the above.
